

**Learning Magazine's
"Make Science Fun" Sweepstakes
Official Rules**

The "Make Science Fun" ("Sweepstakes") is intended to be played in the United States only and shall only be construed and evaluated according to U.S. law. Entries originating from persons located outside of the United States at the time of entry are void. Do not enter this Sweepstakes if you are not located in the U.S. at the time of entry.

1. No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Sweepstakes is open only to legal residents of the 50 United States (except Rhode Island) and District of Columbia who, at the time of entry, are 21 years of age or older, are currently employed either full-time or part-time in the field of education as classroom teachers in grades preschool through-grade 12 and are located in the United States. The Education Center, Inc. ("Administrator"), publisher of Learning Magazine, is administering certain aspects of this Sweepstakes on behalf of the Sponsor. TruGreen Limited Partnership is the Sponsor of this Sweepstakes. 2. How to Enter: Visit www.themailbox.com/mybotanicplanet to enter. Sweepstakes Entry Period starts on October 1, 2013, and ends at 11:59 p.m., ET, on December 17, 2013, ("Sweepstakes Entry Period"). All entries must be received by Sponsor by 11:59 p.m. ET on December 17, 2013. Entrants must follow the online entry instructions and provide complete, accurate, and truthful information in all of the information fields on the entry form. In addition, additional entries will automatically be provided to entrants who follow the entry page instructions to send one or more pre-designed messages to colleagues or friends to inform them about this Sweepstakes. The Administrator will use a tool to track such messages, and for each message sent by the entrant to a different, unique recipient, the entrant sending the message will receive an additional entry into the Sweepstakes, irrespective of whether the message recipient enters. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. Sponsor is not responsible for lost, late, incomplete, or misdirected entries. Upon receipt, all entries become the property of Sponsors and will not be returned. Receipt of entries will not be acknowledged. 3. Drawing: Winners will be selected in a random drawing by Judging Entity ("Judge") conducted on or about December 18, 2013, from among all eligible entries received. Judge will be selected by Administrator. All decisions of Judge are final. By participating, entrants agree to abide by and be bound by the Official Rules and by the decisions of the Sponsor, Administrator, and Judge (if applicable), which are final and binding in all matters relating to this Sweepstakes. Entrants are responsible for

compliance with all applicable laws. Winners will be notified by email, telephone, or U.S. mail. Odds of winning depend on the number of eligible entries received. Entrants who follow the instructions to send messages to colleagues and friends to invite them to the Sweepstakes page may have a greater chance of winning as a result of having more entries in the entry pool.

4. Prize: Prizes are not transferable by winners and no prize substitutions will be allowed, except in Sponsor's sole discretion due to unavailability of a featured prize.
